



Installation:

1.ENSURE POWER IS SWITCHED OFF PRIOR TO INSTALLATION.

2. These units are suitable for connection to a 240V AC 50Hz power point.

3. The BOYD LED WALL TASK LAMP is designed for mounting on the wall only.

4. This unit uses an integral wall mounting bracket, locate the wall mounting bracket (F).

5.Use the wall mounting bracket as a template to drill 4 wall mounting holes (G).

6.Attach the wall mounting bracket to the wall using a fixture system suitable for the wall type.

7.Attach the lamp to the bracket by aligning the lamp slot onto the bracket screws then screw the side lamp secure screws (H) until tight.

8.Plug in the power supply plug into power point and turn the switch on.

9. Press the Light ON/OFF switch (B) to turn ON or OFF the LED light.
